



2011 SEIU LOCAL 521 CONSTITUTIONAL CONVENTION DELEGATE

Eligibility Requirements:

- I. You **must** be a member in good standing from your chapter for a continuous period of at least one (1) year.
- II. You should be able to attend the convention, scheduled October 7-9, 2011 in San Jose, CA, as well as several short chapter meetings.
- III. You will need to take your own time off of work to attend the convention. **NO lost time will be reimbursed by Local 521.**

Obtaining Signatures:

Each nominee **must** obtain signatures from their chapter members. **Only full members in good standing (not service fee payers) may sign a petition.** *There are spaces for additional signatures in the event one of your signatures is invalid (this is optional). The number of signatures you require is dependent on the size of your chapter. See www.seiu521.org for lists.

- Small chapters (1 - 199 members), members of our Homecare chapters, and retired members: **10** signatures or half the chapter membership, whichever is smaller.
- Medium chapters (200 - 1,999 members): **20** signatures.
- Large chapters (2,000 or more members): **30** signatures.

Three ways to Return Your Nomination Forms

- 1) Return by US Mail. Must be postmarked by August 26, 2011.
- 2) Fax or hand-deliver by 5:00pm on August 31, 2011 to one of the offices listed below.
- 3) Scan and e-mail them to 521admin@seiu521.org by 5:00pm on August 31, 2011.

It is your responsibility to meet the timeline. Any nominations postmarked after 5:00 p.m. on August 26, 2011, or received by the union office after 5:00pm on August 31, 2011 will not be considered.
