Certification of Results

The American Arbitration Association, having been authorized by SEIU, Local 521, conducted an election by mail ballot and in-person voting for the 2019 Officers, Delegates and Trustees.

In-person voting took place at 88 designated union locations at various times from January 7 to January 17, 2019. Additionally, mail ballots were sent to designated union members on January 4, 2019 with a return date no later than 9:00 a.m. on Thursday, January 17, 2019.

The return mail ballots were checked off against the eligibility list provided to the American Arbitration Association by SEIU, Local 521. The business return envelopes and the secret ballot envelopes were then opened and the ballots were removed and tabulated in the presence of observers. Secrecy of the ballots was maintained at all times.

The in-person eligibility verification was conducted by SEIU staff, and the American Arbitration Association provided all other services, including maintaining security of the ballots and ballot boxes for the duration of the voting period (January 7 – 17, 2019).
