Over the past few months, members have voiced their priorities in our negotiations:

1. Santa Clara County Must Work for Everyone, Not Just the Wealthy Few

- a. Working together for workers and our community to have accessible and affordable housing and child care is essential.

2. Santa Clara County Workers and Residents Deserve Dignity and Respect

- a. Fixing our broken realignment process, providing fair compensation to people with valuable language skills, and providing a path to permanent employment for part-time and temporary workers.
- b. Hostile and bullying environments are not conducive to respectful workplaces. When we aren't treated with respect, it impacts our morale and our ability to provide quality services to our Santa Clara County community.
- c. Unreasonable workloads impact us every day; excessive overtime wastes money and burns people out, and disciplining people with excessive caseloads is unfairly punitive. Without enough staff to provide critical services to our community, County residents suffer. For Santa Clara County to work for everyone, we need adequate staffing.

- d. Hiring practices in the County are not consistent nor ensure fairness for employees. We need to have more efficient and effective hiring practices that protect workers and provide everyone an equal opportunity without bias.
- e. Due to the rising cost of living, the ability to retire with dignity is more important than ever for County workers.

3. Santa Clara County Can Do More To Balance the Scales for Working People

- a. We aim to work together as equals to make Santa Clara County a thriving community filled with opportunity for everyone. But overreach and abuse of power by County management that violates the Meyers-Milias-Brown Act or our contract is not acceptable. No management has the authority to ignore or supersede the law and any abuse of power requires us to stand up and fight back.
- b. Expensive contractors come and go in the County to the tune of millions—yet when things go wrong, it is SEIU 521 members who come behind them to fix what they left unfinished or did wrong from the start.
- c. All workers deserve wages that will allow them to live and work with their families in our county.

As of July 25, the County of Santa Clara has violated it's obligation to bargain over issues that are directly related to our priorities:

1. County unilateral changes to release time for Roads and Airports Department Leaders and retaliation for protected union activity
2. Department of Family and Children's Services failure to meet and confer on re-organization which impacts workers caseload, client safety and working conditions
3. Unilateral imposition of Reclassification Study of Social Worker Coordinator I/II
4. Unilateral changes for HSR's at Santa Clara Valley Medical Center
5. Denial of release time for Union leaders across the County and the County's continuing failure to respond to our requests
6. The County's failure to notice and meet and confer with our Union on various add/delete positions across county departments. Failure to provide relevant and necessary information related to current negotiations and failure to bargain in good faith with limited movement.
7. The County has failed to provide a safe environment

for workers at the Department of Family and Children Services (DFCS) Receiving, Assessment and Intake Center (RAIC) where children are inadequately housed until placement is found and small children and workers are subjected to physical harm.

The County continues to violate our contract (Memorandum of Agreement) and the Meyers-Milias-Brown Act which mandates the employer bargain in good faith on any changes in wages, hours and working conditions. For these reasons, we must take action collectively. We can no longer wait for the County to talk about just culture and mutual respect—we must demand respect and dignity now. Workers will no longer be silenced by the County's blatant disregard for our contract, our workers and our community which relies on our services.

As of July 25, 2019, our SEIU 521 Negotiating Team has authorized to call an Unfair Labor Practice Strike Vote. Members Only will be able to vote for this strike authorization in accordance with our Santa Clara County Chapter Bylaws. Voting will be August 5 through August 23, 1:30 p.m.

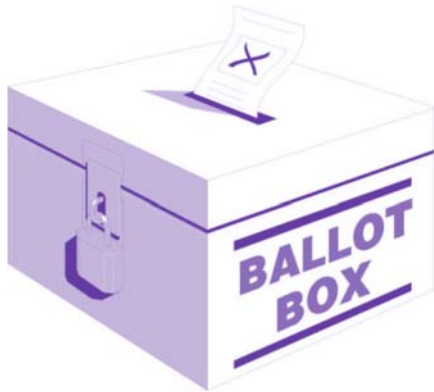
