#### CHIEF ELECTED OFFICER

(Not Contested)



I'm Riko Mendez, Chief Elected Officer of our union, SEIU Local 521. Two years ago, member leaders came together to rebuild our union into one that thrives in the face of extreme anti-union attacks. I look forward to continuing our progress by partnering with you and lifting up the voices of our 40,000 employees across our union.

In 2018, labor faced our most challenging year. With Janus, the Supreme Court decided in favor of the greedy few and ruled against all working people. This case was brought by billionaires seeking to rig

the rules in their favor. Their plan is to divide us against each other. Thankfully, we saw this coming and created a plan to win. To continue winning, we must come together and stand up for each other. Today, we have a strong, vibrant union made up of leaders who have renewed their union commitment.

Two years ago, we committed to: protect our progress, build power in our worksites/communities, ensure transparency/accountability, and secure our future for our families. In the past two years we have made significant progress towards these goals by:

- Improving member communication and providing relevant union information with our new member-only online portal: MemberLink.
- Strengthening contracts and representation by launching our new Steward Training Program. In 2018, more than 200 stewards were trained.
- Winning strong contracts in Kern, Fresno, and San Mateo Counties with member-led campaigns and the highest member engagement in our union's history.
- Filling vacancies on our Executive Board, which increased participation in our decision-making process and Improved transparency and accountability.
- Increasing our political power and electing government leaders who respect all of our families and will govern for all of
  us.
- Renewing our efforts to grow our union by supporting thousands of Childcare Providers who have been fighting for years to gain the right to form a union.

Our work is far from over. Janus was just the beginning. In 2019, billionaire-backed, anti-worker organizations will intensify their efforts to divide us. They will continue to fund organizations, like the Freedom Foundation, to deceive us into dropping our membership and tell us we are better off alone. They will say things like: "give yourself a raise, drop your membership", but their true intention is to weaken our union. Our "Together We Win" team has a plan to win. It starts with talking to our co-workers and sharing what's at stake, and educating new employees about the power of union membership.

No matter our differences, we all want similar things: fair returns for our work and better futures for our families. To win, we need to join together with people from all walks of life to fight for our future, just as we won better wages, safer workplaces, and civil rights in our past. Our united voice is powerful. Vote for me and together, we can win for our families. Vote <u>Together We Win</u>.

#### TRUSTEE-AT-LARGE



We face numerous challenges in maintaining and expanding the protections, opportunities, and outreach efforts that keep SEIU Local 521 strong. Many of these challenges are *external*, like fighting off ballot measures meant to gut our pensions; adapting to and minimizing the Janus decision's attack on Agency Shops; and resisting attempts by reactionary forces to poison the minds of voters against us by spreading lies and distortions about what unions do and who union members are. We all know what's at stake and how essential it is to continue standing together to defeat these attacks! Your votes for our Local's Officers and Executive Board Delegates are a vital part of maintaining workers' strength and spreading our Stronger Together message.

By comparison, a Trustee often plays a more subtle (but no less important) part in helping our Local succeed with its *Internal* challenges, especially to ensure that our Local uses its power and resources as effectively and cooperatively as possible. Helping strike the right balance between those two types of challenges was one of the main priorities that I focused on three years ago, when I became a Trustee at Large. I've since learned how an experienced and diplomatic Trustee can play a key role behind the scenes to help coordinate our Local's public efforts and, when needed, to help resolve internal disagreements or difficulties that sometimes arise when committed people work together in strenuous efforts to win justice for working people. I've also learned that the only genuine way to carry out a Trustee's role is to always respect our members' differing viewpoints and diverse backgrounds, all of which make us stronger!

I respectfully ask for your vote, to allow me the privilege to serve a second term. My experience as a Steward, a Chief Steward, a Negotiator, and for the last 10 years as Chair of Santa Clara County's Election Committee, have helped me gain the insights, skills, and understanding that I believe are a good match for a Trustee's duties. My Election Committee teammates and I have found creative, durable, and inclusive solutions to several thorny (and sometimes unprecedented) issues, some of which resemble the challenges our Local faces.
