**Article VI Section 3** (excerpt from SEIU 521 Bylaws) Retired members may choose to retain full membership by paying the minimum level of full dues of an active, regular member. Any retiree paying full dues shall be eligible for nomination and election to any office of the Local Union for which he/she is eligible, according to his/her region of domicile including the Executive Board Delegate of the Retiree Chapter.

**Option 2:** Annual dues \$62.52 or Monthly dues \$5.21

**Article VI Section 3** (excerpt from SEIU 521 Bylaws) A member, who has retired in good standing from a jurisdiction represented by SEIU 521 may join the Retiree Chapter of the Local Union. This qualifies the member for voting in any Retiree Chapter or local wide election.
